TENDER DOCUMENT FOR SUPPLY, INSTALLATION OF IRON GATES AT TCP'S GRAIN GODOWN, PIPRI, SITUATED AT MAIN NATIONAL HIGHWAY, OPPOSITE GULSHAN-E-HADEED, KARACHI

INVITATION FOR BIDS:

Trading Corporation of Pakistan (Pvt.) Ltd. (TCP), Karachi, a state-owned commercial organization working under the administrative control of Ministry of Commerce, Government of Pakistan, invites sealed bids from reputable firms/sole proprietorship for supply, fixing of Iron Gates at it's Rice Grain Godow Pipri, situated at Main National Highway, Opposite Gulshan-e-Hadced, Karachi.

2. **SUPPLY AND INSTALLATION OF GATES:** - The new main gates shall be made with complete new material including new Iron Bars / Plates, and to be fixed / installed with Concrete / Cement. The gates to be coloured with two coats of Oil Enamel (Oil Paint) after applying Anti-Rust Enamel and fixing.

3. **SPECIFICATIONS/REQUIREMENT OF GATES:** - Sizes and location and sizes / dimensions / for gates are as under: -

4. **DESIGN OF THE GATES/LEAVES:** All the new gates/leaves, shall be with the designs/specifications/dimension as per Annexure-I: -

5. **BASIS OF OFFERS/PRICE:** -

- Offers should be valid for thirty days w.e.f. date of opening of tender;
- Lump sum rates to be quoted for supply and installation of gates as per Annexure-II; subject to terms and conditions of this tender document.

6. **BID EVALUATION CRITERIA:** -

- Bids will be evaluated solely on basis of price subject to their conformity with terms & conditions of bid document.
- TCP may seek clarifications within the validity of Offers.

7. **AWARD OF CONTRACT & COMMENCEMENT OF WORK: -**

- a. The work will be assigned to lowest evaluated bidder;
- b. The Successful bidder / contractor shall start the work immediately, and will complete the entire work within a reasonable time. The timeline shall be given in the award letter, according to nature of award; and
- c. The Successful bidder / contractor shall perform all the allied matters, which includes removal of existing gates/walls, color and white wash of the reconstructed walls/concrete and arrangements of all the material, required resources etc.

8. **BID BOND / PERFORMANCE GUARANTEE: -**

- a. Bid shall be accompanied in original by a Bid Bond equivalent to five percent (5%) of the offered rates in the form of only Demand Draft or Pay Order in favour of "Trading Corporation of Pakistan";
- b. Bid Bond(s) of the unsuccessful Bidder(s), including those whose Bid(s) is/are not accepted for any reason, the bid(s), will be returned within seven (7) days of the award of tender to the successful Bidder(s);
- c. Bid Bond(s) of the successful Bidder shall be retained as Performance Guarantee;
- d. The Performance Guarantee of successful bidder shall be returned after satisfactory completion of entire awarded work;
- e. The Performance Guarantee of successful bidder shall be forfeited, Commits any breach of contract or fails to fulfill any terms or conditions of the contract.

PAYMENT: -

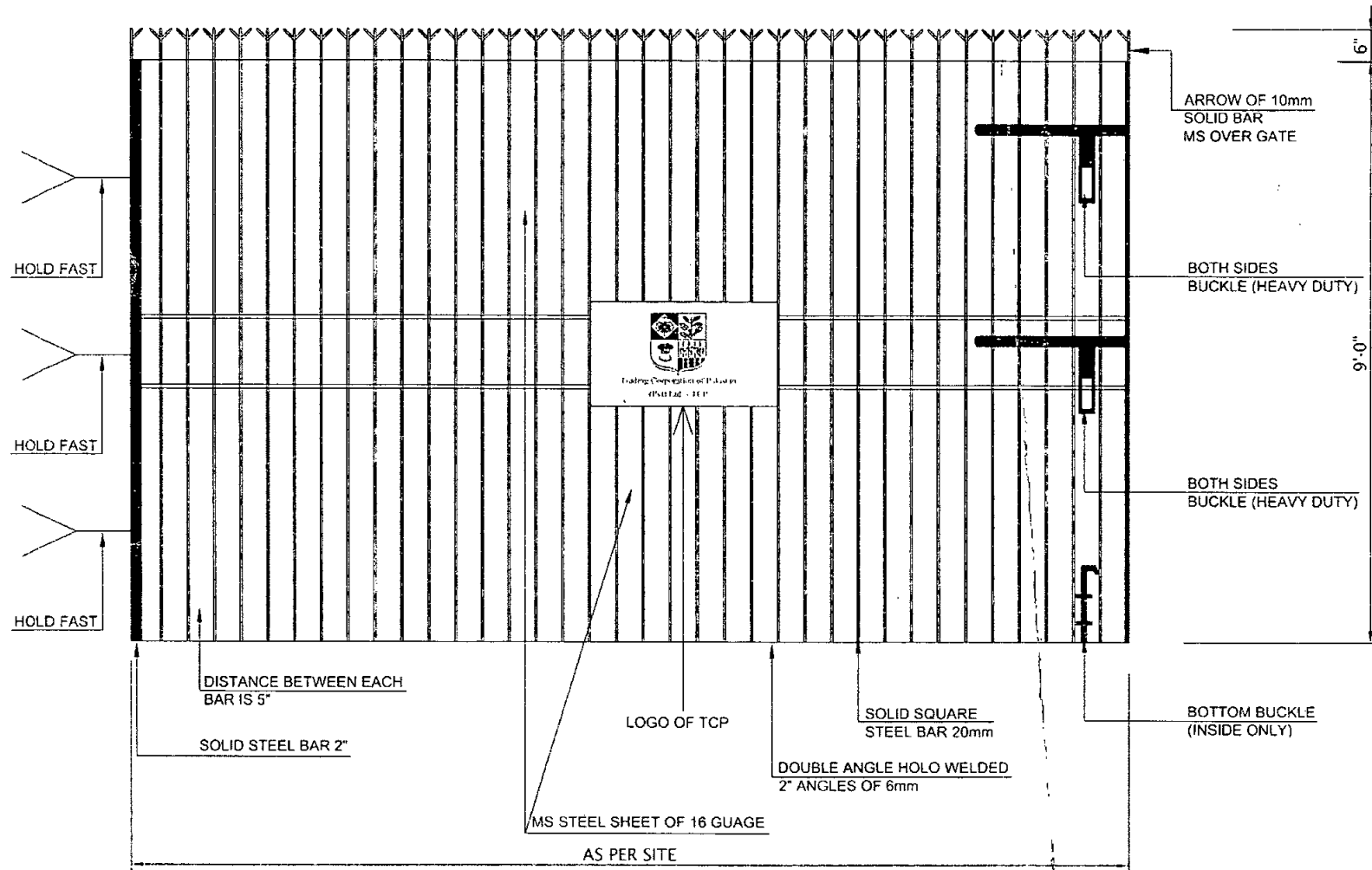
- a. Payment shall be made after completion of entire work subject to furnishing of work satisfactory report by the Incharge Pipri Godown.
