

DEFINITION AND INTERPRETATIONS

- a) "EMPLOYER" means the Trading Corporation of Pakistan (TCP).
- b) "EMPLOYER'S REPRESENTATIVE" means a "PERSON/CONSULTANT" designated by the Chairman, Trading Corporation of Pakistan (TCP) to act on behalf of the EMPLOYER in all matters regarding the Complete Supply, Installing, Testing & Commissioning of Eight (8) two (2) Ton Inverter Tower/Floor Standing Air Conditioners with T-3 Compressor& Five (5) 1.5 Ton Wall Mounted Air Conditioners with T-3 Compressor (with warranty).
- c) "WORKS" Complete Supply, Installing, Testing & Commissioning of Eight (8) two (2) Ton Inverter Tower/Floor Standing Air Conditioners with T-3 Compressor& Five (5) 1.5 Ton Air Conditioners with T-3 Compressor (with warranty) as per the directives of the Employer's Representative.

PROCUREMENT OF AIR CONDITIONERS WITH T-3 COMPRESSOR

1. <u>INVITATION FOR BIDS</u>:

- 1.1 Trading Corporation of Pakistan Private Limited ('TCP') intends to purchase/install Eight (8) 2Ton Inverter Tower/Floor Standing Air Conditioners with T-3 Compressor& Five (5) 1.5 Ton Wall Mounted Air Conditioners with T-3 Compressor (with warranty) at TCP's Principal Office, 4th and 5th Floor, Block-B, Finance & Trade Centre, Shahra-e-Faisal, Karachi.
- 1.2. The contract for the supply and installation of brand-new Eight (8) Two (2) Ton Inverter Tower/Floor Standing Air Conditioners with T-3 Compressor Five (5) 1.5 Ton Wall Mounted Air Conditioners with T-3 Compressor (with warranty) (as defined in clause 2), shall be governed by the relevant rules & regulations, laid down by the Federal Government or concerned agency/ies, authority/ies.
- 1.3. TCP invites sealed Bids from reputed Original Equipment Manufacturer (OEM)/Authorized Dealer/Sole Authorized Dealer/firms/companies having valid NTN, GST/STN Registration and are on Active Taxpayers list of FBR /SRB and are fulfilling all legal criteria of registration may participate in the tender for the Procurement of eight (8) Two (2) Ton Inverter Tower/Floor Standing Air Conditioners with T-3 Compressor& Five (5) 1.5 Ton Wall Mounted Air Conditioners with T-3 Compressor (with warranty).
- 1.4. Tender will be conducted under National Competitive Bidding pursuant to 'Single stage one envelopes procedure' as per Rule 36(a) of Public Procurement Rules 2004 (PPR 2004) and is open to all eligible participants of tender as defined in the PPR 2004.
- 1.5. Interested bidders may submit their bids/offers alongwith required bid money on the basis of single stage one envelope procedure to be dropped in the tender box placed at the reception counter of TCP at 4th Floor, Block-B, Finance & Trade Center, Shahra-e-Faisal, Karachi, up to 1100 hours on Monday 09-10-2023. The bids shall be opened in the TCP's Board Room on the same day at 11:30 hours, in the presence of bidders or their authorized representatives who may wish to be present.

2. SCOPE OF TENDER:

- 2.1 Eight (8) two (2)Ton Inverter Tower/Floor Standing Air Conditioners with T-3 Compressor and Five (5) 1.5Ton Wall Mounted Air Conditioner with T-3 Compressor (with warranty).
- 2.2 Extra Copper piping (for each Air Conditioner).
- 2.3 Wiring Inner to Outer with rubber (for each Air Conditioner).
- 2.4 Flux & Electric 100% Copper wire coil(s) (for each Air Conditioner).
- 2.5 Iron Angles (for each Air Conditioner).
- 2.6 Circuit Breaker (for each Air Conditioner).



- Complete Supply, Installing, Testing & Commissioning of Eight (8) two (2) Ton Inverter 2.7 Tower/Floor Standing Air Conditioners with T-3 Compressor& Five (5) 1.5Ton Air Conditioners with T-3 Compressor (with warranty) as per the directives of the Employer's Representative.

- 2.9 Any other item required.

GENERAL TERMS & CONDITIONS: 3.

- No bidder shall be allowed to alter or modify his bid after the bids have been submitted. However, 3.1 TCP, being the procuring agency, may seek and accept clarifications to the bid in written that do not change the substance of the proposal.
- 3.2 Bids which are incomplete, not sealed, or late or submitted in other than specified manner shall be returned un-opened.
- The proposals should not have any over-writing or cutting. Bids with any of the aforementioned 3.3 defects will not be considered.
- 3.4 The bids received by fax or e-mail shall not be accepted.
- 3.5 Only one authorized representative per participant of the tender will be allowed to attend the bid opening session.
- 3.6 The site can be visited on any working day i.e., Monday to Friday between 08:30 AM to 4:00 PM.
- 3.7 The participants of the tender shall bear all costs associated with the preparation and submission of their respective Proposals and TCP will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the prequalification/enlistment process.
- 3.8 TCP requires that participants of the tender under their contracts observe the highest standard of ethics during the procurement and execution of such contracts. In pursuit of this policy following terms are defined as hereunder:
 - a. "Corrupt practice" includes offering, giving, receiving, or soliciting, directly or indirectly, of anything of value to influence improperly the actions of another party.
 - b. "Fraudulent practice" includes any act or omission, including a misrepresentation, that knowingly or recklessly misleads, or attempts to mislead, a party to obtain a financial or other benefit or to avoid an obligation.
 - c. "Coercive practice" includes impairing or harming, or threatening to impair or harm, directly or indirectly, any party or the property of the party to influence improperly the actions of a party.



3.9 Clarification, if any required requirement may be obtained through written inquiry before the bids are opened. The same shall be communicated to all the bidders. Such questions shall be received not later than 7 days before the date of opening of the Tenders.

4. WARRANTY:

4.1. The successful bidder shall at his own expense rectify any defects/shortfalls/deficiencies in work.

The warranty period shall be as per the standard warranty provided by the OEM.

5. BASIS OF OFFERS/ PRICE:

- 5.1 The price shall be quoted in Pak Rupees only.
- 5.2 The quoted price shall be inclusive of all taxes, expenditure, including transportation, installation, electrical wiring charges, warranty charges, and other charges, if any, whatsoever.
- 5.3 TCP shall only be responsible for the price to which the contract shall be awarded. Any claim beyond this amount shall not be entertained, under any circumstances.
- 5.4 The bidders will have no rights to change their stance, in respect of price, specification and requirement once the bid is dropped.
- 5.5 TCP reserves the right to accept or reject any or all offers wholly or partially as per PPR-2004.

6. **ELIGIBILITY CRITERIA:**

- 6.1 The firm/bidder must provide NTN, GST registration number issued by Federal Board of Revenue/Sind Revenue Board. Income Tax, GST/SST as applicable must be mentioned separately.
- 6.2 Bidder must be in Active Taxpayer list/verifiable from FBR website (attach Copy).
- 6.3 The Bidder must attach valid Distributorship/Dealership/Partnership certificate or certificate of incorporation from the original manufacturer/principal authorizing the bidder to sell their products in Pakistan particularly Air conditioners valid till December 31st, 2023.
- 6.4. The bidder should certify the period / experience since their firm is involved in this business (which should not be less than three (3) years for eligibility) and the period of firm's association with the principal whose products are being offered.
- 6.6. The bidder should have accomplished two similar projects during the last two (2) years. The list of such projects should be attached with the name and contact numbers of the clients.
- 6.7 List of major clients in last two (2) years.
- 6.8 The firm(s) who defaulted on its contract(s) awarded by TCP or any other Government or Semi Government entity is not eligible to participate in the tender. The firm(s) who have not fulfilled their



- contractual obligation with TCP shall also not be eligible to participate in the Bid(s) unless they clear their dues alongwith penalties or fulfill their contractual obligations with TCP.
- 6.9 The firm should not be blacklisted by TCP or any other Government or Semi Government entity. An Rs. 100/- affidavit to this effect shall be attached.

7. BID EVALUATION CRITERIA

- 7.1 Lowest responsive Bidder shall be awarded the contract.
- 7.2 In case the first lowest bidder fails to provide the required services or TCP is not satisfied with the provided services, TCP reserves the right to obtain the services from Second lowest bidder. In case the second lowest bidder fails to provide the required services or TCP is not satisfied with the provided services, TCP reserves the right to obtain the services from third lowest bidder.
- 7.3 TCP can ask for any details information in respect of the offer submitted by the bidder, under the provision of Public Procurement Rules, 2004. However, the original bid shall be treated for the evaluation purpose.

8. BID VALIDITY:

The bid shall be valid for a period of 60 days from the date of opening of the bids & further extendable for the same period as per the mutual consent of the parties.

9. <u>BID SECURITY / PERFORMANCE GUARANTEE</u>:

- 9.1 Bid shall be accompanied in original by a Bid Security worth Rs.200,000/- in the shape of Pay Order/Bank Draft in favor of "Trading Corporation of Pakistan (Pvt.) Limited.
- 9.2 Bid Security of the unsuccessful Bidder(s), including those Bid(s) which are not accepted for any reason, will be returned after award of tender to the successful Bidder(s).
- 9.3 Successful Bidder shall be required to submit a Performance Guarantee within 7 days of issuance of award letter, equivalent to ten percent (10%) of the quoted amount in the shape of a Demand Draft or Pay Order in Pak Rupees in favor of Trading Corporation of Pakistan (Pvt.) limited, which will be returned after successful completion of the warranty period, upon the satisfactory working of Air Conditioners, including other services, in accordance with Tender Terms & Conditions and settlement of any/all claims.

10. FORFEITURE OF BID BOND/PERFORMANCE GUARANTEE:

- 10.1 The performance guarantee shall be forfeited if the bidder(s) fails to accept the award letter or fails to supply the goods within the specified period as per contracted terms and conditions.
- 10.2 Commits any breach of contract or fails to fulfill any terms or conditions of the contract.



11. SUBMISSION OF BIDS:

- 11.1 Interested parties may submit their bids in sealed envelopes to be dropped in the Tender Box placed at reception Counter of TCP at 4th Floor, Block "B", Finance & Trade Centre, Shahra-e-Faisal, Karachi on Monday 09-10-2023 latest by 1100 hours (11:00 am). Bids received through fax, email, cable, courier, or any other means except as prescribed above shall not be considered.
- 11.2 The bids received will be opened at 11.30 am on the same day (thirty minutes after the deadline for submission of bid) in the TCP Board Room in presence of bidders or their authorized representatives who may wish to be present.
- 11.3 All bids must be submitted on the prescribed proforma given at Annexure-I (along with original receipt of purchase of tender documents in the name of Bidder).

12 **DOCUMENTS CONSTITUTING CONTRACT:**

12.1 The IFB (Invitation for Bids), the Terms & Conditions of Tender, Bid/offer submitted by the bidder and the Letter of acceptance Issued by the TCP shall constitute the Contract between the Buyer and the Seller.

13. **CHANGE IN ORDER:**

13.1 TCP at any time by a written notice to the vendor make changes in the scope of the work. The mutually agreed changes shall be considered as a part of the work & the provision & conditions of the contract/tender documents shall apply.

14. <u>COMPLETION OF WORK:</u>

- 14.1 The job is Supply, Installation, Testing and Commissioning of Eight(8) 2Ton Inverter Tower/Floor Standing Air Conditioners with T-3 Compressor& Five (5) 1.5 Ton Wall Mounted Air Conditioners with T-3 Compressor (with warranty) as per the directives of the Employer's Representative.
- 14.2 The work is not to be considered complete until the TCP has certified in writing that it has been completed. The warranty period shall commence from the date of completion certificate.
- 14.3 Any & All material/ parts required to complete the above task in a satisfactory manner will be arranged by the Successful Firm/Company.

15. SUBLETTING OF WORK:

15.1 Upon selection, the selected bidder shall not be allowed to transfer, assign, pledge, or sub-contract its rights and liabilities under this agreement to any other service provider or organization.

16. WARRANTY PERIOD:

16.1 The successful bidder shall at his own expense rectify any defects/shortfalls/deficiencies in work. The warranty period shall be as per the standard warranty provided by the OEM.



17. LIQUIDATED DAMAGES

- 17.1 If the successful bidder fails to complete the Work or perform the Services specified in the Tender Documents/Contract within the stipulated period/ scheduled time specified by the successful bidder in his bid, TCP, without prejudice to any other remedies, shall deduct from the bills or any other due payments/ guarantees, as liquidated damages, a sum equivalent to 0.1% per day of the value the Contract, until actual completion of the Work or performance of the Services.
- 17.2 The payment of liquidated damages shall not relieve the Vendor from performing and fulfilling all its obligations under the Contract and nor shall the rights and entitlements of the TCP be affected or reduced in any manner.
- 17.3 However, if the delay is over 30 days, the TCP reserves the right to terminate the Contract. Any and all pending invoices incurred by and/or on part of the successful bidder shall not be paid by TCP.

18. **ESCALATION IN PRICE:**

18.1 It is clear that there is no price variation clause in the tender. Therefore, all the unit prices quoted shall be fixed, irrevocable & valid till the completion of work and shall not be any variation on any account.

19. **REJECTION/DISQUALIFICATION OF BIDS:**

- 19.1 TCP may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. TCP shall upon request communicate to any supplier or contractor who submitted a bid or proposal the grounds for its rejection of all bids or proposals but is not required to justify those grounds.
- 19.2 TCP shall disqualify a firm if it finds at any time that the information submitted by the firm concerning its qualification was false and materially inaccurate.

20. **SELECTION OF FIRM:**

20.1 A company/firm will be selected after an open and transparent tendering process in accordance with Public Procurement Regulatory Authority (PPRA) Ordinance, 2002, and Rules, Regulations and Guidelines.

21 <u>DELIVERY / INSTALLATION SCHEDULE</u>:

- 21.1 The supply and installation of the Air Conditioners shall be positively completed within 20 days or earlier, after award of the contract.
- 21.2 The bidder shall be responsible for arranging the smooth delivery and installation of Air Conditioners, according to the entire satisfaction of the TCP.



22 AFTER SALE SERVICE AND ASSISTANCE:

- 22.1 The bidder shall provide the free service and warranty of the Air Conditioners, after completion of supply/installation of the Air Conditioners during the period of the warranty.
- 22.2 The bidder shall sign a Service Level Agreement, after the completion of the warranty period.
- 22.3 The bidder should clearly mention the maximum time required for the replacement of the affected part(s), in case of warranty claim from principal and incase of more than 72 hours the vendor should replace the affected part(s) from their in-house inventory.
- TCP can call the vendor for assistance on TCP's premises any time during office hours. The bidder shall be responsible to respond within 2-3 hours, upon receipt of intimation from TCP.

23. PAYMENT:

- 23.1 The payment shall be processed by TCP, after successful completion of supplying, installation, and successful working, as per required terms &conditions, after one week of installation / configuration.
- 23.2 The seller shall submit the following documents to process the payment: -
- 23.3 Seller's Invoice.
- 23.4 Warranty Certificate to be issued on Stamp Paper, alongwith signed copy of document, as per Contract.
- 23.5 Copy of Sales Tax Certificate.
- 23.6 Copy of Income Tax Certificate / NTN Certificate.
- 23.7 All the applicable taxes (Federal, Provincial & any other) will be deducted as per prevailing government policy.

24 <u>CANCELLATION OF CONTRACT:</u>

24.1 If the Seller fails to provide and delivery the Air Conditioners, as per specifications and within the specified period, the TCP shall be entitled at his option to cancel the contract and recover the damages besides forfeiture of Performance Guarantee. The Buyer shall not be liable to any risks and costs whatsoever in consequence of such cancellation of the contract.

25 **ARBITRATION**:

Any difference or dispute or liability of whatsoever nature arising out of the contract or in any way relating to the contract or to its construction or fulfillment should be settled as far as possible, amicably between the Buyer and Seller. Should the parties fail to come to an amicable settlement the same shall be referred to the Chairman TCP, for final decision. The decision of Chairman TCP shall be final and binding on both the parties i.e., Seller &TCP.
